Update from Chris Donley

- Chris announced that he is leaving Huawei and will be stepping down as the CVC Chair after ONS. The Committee expressed appreciation for Chris's contribution and leadership.
- The VNFSDK project is going through PTL election. Heather, at the end of the call, encouraged members to get involved there on the technical implementation side.

Finalizing Qualified Lab Strategy

- The Committee discussed the suggestion to include CI/CD tooling in lab strategy. Morgan said vendors will have more confidence and trust in a lab if the lab is able to set up and run CI/CD but acknowledged that it would be difficult to implement it as a requirement. Lincoln noted that labs need a relatively stable infrastructure environment, e.g. based on a specific release/version that's lined up with testing. Additionally, it's difficult to provide specific guidance around CI/CD to labs at this point in time. The Committee decided to make it a recommendation or expectation that qualified labs should develop and maintain a working knowledge of the LFN Project's CI/CD tooling.
- Lincoln has added the CI/CD recommendation under the Expectations section of the document. The latest Lab Strategy document can be found on the CVC's wiki page.

OpenLab

Morgan did a quick demo of OpenLab. He will also demo it at ONS next week. The idea is to enable clients to
run tests on this community lab to sort out and resolve any issues prior to formally contacting the lab to run
the test. Heather added a time slot at the unconference room https://wiki.lfnetworking.org/display/LN/Open+Networking+Summit+Europe+2018+-+Unconference+Topic+Proposals to make this a wider
and deeper discussion at ONS.

Finalizing Governance Document

- Chris did a final run through of the governance document with the attendees.
- Chris noted that CVP Verified in the document is now a placeholder that will be replaced with the LFN program name as recommended by the marketing team. Heather suggested adding "and/or other related program marks" to provide enough coverage as the branding discussion continues.
- Steven raised the question of whether infrastructure such as a radio head interfacing with ONAP would be covered in the current scope of the governance document. Chris noted that the requirements for such items haven't been defined as references to test against. In order to accommodate potential future addions, the attendees agreed with the addition (in bold) to "application or **other devices** that interface with that infrastructure."
