VNF Validation Testing (MVP work)

 validation testing may use a separate automation framework (i.e. tests are not run using the Dovetail container, but could be run by
 the Integration Project's Robot scripts).
 - How is the compliance testing also run as a requirement for this testing (currently run by Dovetail or VVP)?
 - We do need the compliance and validation results / report to be a single submission to the Dovetail portal.
 - Diagram Question 5: Common Library show / demo for the User Story may help define this better.
 - Open Discussion Point 1: Test Environment Who owns this item, how is it defined?
 - Need to describe the open stack instance that is required, ONAP version, etc.
 - For the "hardware" requirements, is it possible to point to something like the OPNFV Pharos definitions, or can we refer to a definition coming from CNTT as a reference architecture.
