 - Major progress: Have decomposed the "problem" into the questions list below
 - **Summary:** VNF Evolution will be based on the CNTT rls # and driven through VNF Profiles
 - **To-do:** Close the following questions, including technical and policy related (*language for each bullet needs to be refined and fleshed out*)
 1. In an OpenStack environment, what is the best way to schedule workloads against the correct variant (i.e. revision) of a flavor when using the Compute API? In other words, if there are multiple variants for a given flavor, such as version 1, ver 2, ver 3, etc., what is the best way to utilize the Compute API to instantiate the correct variant for a workload. Two examples are provided, but we are open to other options:
 - a. Create a new flavor every time a new version of a profile is needed, then overload the flavor's name w/ the variant. For example, Basic_v1, Basic_v2, etc. API calls would populate flavorRef = Basic_v2, etc.
 - b. Have a single, static, base flavor name (e.g., Basic), and use a scheduler_hint parameter to identify the variant. In this scenario, API calls would populate flavorRef = Basic, and populate os:scheduler_hints = v2
 - c. Other ideas?
 2. **[CLOSED]** Should profile variant identifiers, which are simply integers, potentially w/ a "v" prefix (e.g., v1, v2, v3, etc.), be kept in lock step w/ CNTT release numbers? For example, profile variants in CNTT Rls *n*, would all be variant *n*. When a new CNTT release is produced, all profile variants will increment to stay aligned w/ the overall rls number. This includes releases where there are no changes to the variants – when the CNTT rls number changes, so does the profile variant identifier associated with that release.
 - a. What are the drawbacks to this methodology?
 - b. What happens if a new CNTT rls comes out and there are no changes to the profile? Do we increment the variant anyway, just to keep it in sync w/ the CNTT rls?
 - c. **CONCLUSION:** We will synchronize the variant numbers w/ the CNTT release number for the time being. We can revisit this policy in the future, if needed.
 3. How are Infra upgrades to be implemented and supported? We propose a make-before-break approach, where upgraded nodes are added to the Infra when convenient, and workloads are cutover to the new Infra once they're certified or replaced with VNFs that are certified for the new profile variant

 - Introduced Generic Fabric Model (GFM) and CNTT Networking initiatives
 - Agreed: Initial GFM objectives, requirements and strategy would be worked out of RM
 - Agreed: If at some point a dedicated GFM workstream is required, it can be created at that time
 - An RM::GFM-specific sub-meeting will be created with scheduling to better accommodate key players

 - Trevor raised additional point; may be a 6th issue - If a site upgrades h/w, but there is NO coincident increment in phase of VNF Evolution (i.e. h/w upgrade, but remains on same CNTT RIs), is that managed / how is that managed? // may require a site-specific vintage identifier (e.g., Basic w/ variant 2b, where 2 is the Evolution phase (CNTT RIs 2) and b indicates it's an additional resource pool of the same VNF Profile variant, but with different h/w). More investigation is required
